# 1. Subject

Installation of a second attachment bracket to the autopilot mounting tray.

# 2. Affected Aircraft

All serial numbers of the model EA400-500 (Extra 500).

# 3. Introduction

The current attachment of the autopilot mounting tray provides one bracket on the left side which also attaches to the audio panel tray.

In accordance with the A/P manufacturer's installation instructions the attachment shall be installed on either side to ensure proper A/P functioning. Hence, the same bracket shall be installed on the right side of the tray, too, using a similar method of fastening.

Compliance with this Service Bulletin will prevent the influence of unsymmetrical operational loads on to the A/P mounting tray and will make sure that the A/P performance is not degraded by the method of installation.

# 4. Compliance Time

SST Flugtechnik GmbH considers compliance with this Service Bulletin recommended.

# 7. Instructions

The following procedures provide detailed installation instructions for the modification of the A/P mounting tray attachment.

#### 7.1. Mechanical installation

#### 7.1.1. Preparation for installation

Prepare the aircraft for maintenance iaw. MM.

- a. Make sure that all switches are in the OFF / NORM position.
- b. Disconnect electrical power from the aircraft (incl. aircraft battery and external power supply) and attach appropriate warning tags.

#### 7.1.2. Removal

- c. Unmount and remove the A/P computer and the Audio Panel from the instrument panel iaw. MM.
- d. Unmount and remove the right IFD iaw. MM.

#### 7.1.3. Installation

- e. Install the 2<sup>nd</sup> attachment bracket in accordance with the assembly drawing.
- f. Re-install the right IFD, Audio Panel and A/P computer iaw. MM.

#### 7.1.4. Return to service checks

g. Check proper functioning of the re-installed units iaw. MM procedures.

#### 8. Weight and balance

The influence on the W&B of the aircraft is negligible.

### 9. Electrical load analysis

No change.

### 10. Operating instructions

No change.



### **11. Instructions for continued airworthiness**

Proper condition and attachment of the installed bracket shall be checked in accordance with the current scheduled maintenance checks as already applicable for the autopilot computer's mounting tray.

This SB shall be inserted into the aircraft's documentation to be available for each maintenance or repair event of the aircraft.

This service bulletin is effective upon the date of issuance.
