1. Subject

This Service Bulletin provides instructions for the installation of an additional 3,5mm audio jack. The jack is connected to the audio panel PMA8000B or PMA8000Bti (whatever is installed) and enables to connect a cellular phone or other audio device to the intercom using the built-in TEL mode of the PMA8000B(Ti).

2. Affected Aircraft

Optional for EA400-500 MSN 1002 and up.

3. Introduction

This Service Bulletin is issued to introduce the optional 3,5mm audio jack. The jack is connected to the audio panel PMA8000B or PMA8000BTi (whatever is installed, PMA8000B for further reference) and enables the pilot to connect a cellular phone or other audio device to the intercom using the PMA8000B's built-in TEL mode.

7. Required tooling

Standard maintenance tools are required for installation.

8. Instructions

NOTE:

The installer must follow the requirements of the manufacturer's installation manuals listed in conjunction with the supplied wiring diagrams and the instructions listed herein.

8.1. Installation Planning

Carefully read and understand this entire document before beginning with the modification. If any questions arise, contact SST-Flugtechnik GmbH for further instructions.

8.2. Preparation for Maintenance

- a. Make sure that all switches are in the OFF / NORM position.
- b. Disconnect electrical power from the aircraft (incl. aircraft battery and external power supply) and attach appropriate warning tags.

8.3. Removal

- a. Referring to the Maintenance Manual de-install the PMA audio panel.
- b. Referring to the Maintenance Manual, remove the IFD-1 and IFD-2 to gain access to the audio panel wire loom. Do not disconnect wires or hoses, secure the units and provide adequate protection to not damage surrounding equipment.
- c. Referring to the Maintenance Manual, de-install the audio panel connector J1 from the tray.
- d. Referring to the Maintenance Manual remove the Main Switch Panel.
- Referring to the Maintenance Manual remove the pilots arm rest cover plate. Furthermore the lining
 on the pilots LH armrest has to be unmounted to be able to attach the new wire to the existing wire
 loom.

8.4. Installation

- a. For details please refer to the drawings listed in section 6 of this document.
- b. Re-install the side wall cover, main switch panel, the audio panel and the IFDs.

8.5. Modification close-up procedures

- c. Make sure that all switches are in the OFF / NORM position.
- d. Re-connect electrical power, perform the tests iaw section 8.6 and prepare aircraft for release to service.

8.6. Post-installation inspections and tests

In order to check the proper function of the installed jack proceed as indicated by the corresponding pilot's guide (see section 6).
